**Idaho State Lottery
Annual Report on Charitable Gaming
January 1, 2008 to December 31, 2008**

During the period January 1, 2008 to December 31, 2008 there were a total of 219 organizations licensed to conduct Charitable Gaming throughout the state of Idaho, compared to 181 licensed organizations licensed during the same period the previous year. This represents a twenty-one percent (21%) increase in the number of active Charitable Gaming licenses. Page four of this report contains a summary of the number of licenses issued by county.

The total amount of actual contributions to charity generated by organizations licensed to conduct bingo and raffles was \$3,711,444.68. This represents an increase of nearly 16% in the actual contributions to charity from the proceeds of bingo and raffles from the previous year. A breakdown showing gross revenue, cost of prizes/payouts, and administrative expenses for both bingo and raffles is provided on page five of this report.

The Bingo Raffle Advisory Board met on January 10, 2008, March 19, 2008 and July 1, 2008. The Board provided valuable input and worked with Lottery staff in drafting the proposed changes to IDAPA 52.01.02 – Gaming Rules of the Idaho State Lottery Commission which were approved by the Idaho State Legislature during the 2009 Legislative Session.
